- **Basic Needs:** Since March 2020, we have provided over \$108,000 in grocery store gift cards to the families of Highline students in need.
- **Classrooms:** We support basic and innovative classroom needs through our Excel and Impact Grant programs—just this fall we awarded \$15,000 in Excel mini-grants!
- **College & Career Readiness:** We offer a substantial needs-based college scholarship program for both four (4) and two (2) year institutions for our district’s graduating seniors and partner with the district on a scholarship program for outstanding scholar/athletes. Last year, we paid out nearly \$260,000 in scholarships to students in Highline.
