OUR COMMUNITY PROGRAMS SUPPORT STUDENTS WHOSE FAMILIES ARE STRUGGLING FINANCIALLY OR ARE HOMELESS (MCKINNEY-VENTO). THESE SCHOLARSHIPS ARE AWARDED BASED ON NEED, LEADERSHIP, AND ACADEMIC PERFORMANCE. IN 2022, THE FOUNDATION AWARDED 22 SCHOLARSHIPS TO GRADUATING SENIORS, TOTALING \$204,000.

WE SUPPORT ACTIVITIES AND EXPERIENCES THAT EXPAND THE LEARNING PROCESS AND ACTIVELY ENGAGE STUDENTS.
